Planning Commission Report by Alan Johns: The planning commission is updating the ordinance for wind turbines. The zoning board of appeals needs to have a planning commission member appointed to it. The township supervisor and the chair of the planning commission will meet with the county prosecuting attorney and an officer from the sheriff department regarding the river ordinance.

The JCCA Report was given by Barbara McCollom: The JCCA has a balance of \$2,029.00 and issued eight permits for Deerfield Township last month.

The Zoning Administrator's Report was given by Jack Long: Three zoning permits were issued last month.
