Planning Commission Report by Alan Johns. Regarding complaint on gravel company, a letter was sent to complainant informing them the planning commission determined the gravel company had complied with the special use permit. The DEQ also requested a copy of the permit.

The JCCA Report was given by Lynne Wyatt and Jack Long. JCCA has issued a total of 41 permits this year to date.
