Motioned by Walter Nelson, seconded by Lynne Wyatt to approve the contract to apply chip seal to three miles of Meridian Road from M-20 to Baseline Road. Deerfield share estimated at \$33,183.13 with a 10% contingency fee of \$3,318.31 if needed, motion carried.

Discussed paving Baseline Road from Meridian Road to Nottawa Road.

Motioned By Lynne Wyatt, seconded by Walter Nelson to approve the contract to pave Baseline Road from Meridian Road to Nottawa Road. Deerfield Township share \$45,241.21 with a 10% contingency fee of \$4,524.12 if needed, motion carried.

Discussed hiring a new township attorney. Motioned by Dave Garrett, seconded by Walter Nelson to contact Mike Hackett to provide the service, motion carried.
