Motioned by Walter Nelson seconded by Randy Martin to approve option one which includes reconstructing the intersection at Vandecar Road and repaving from a point one quarter mile west of Vandecar Road to a point one hundred feet west of the North Branch Chippewa River Bridge. The total cost will be \$230,000.00, and to apply for a 2% grant from the Saginaw Chippewa Indian Tribe for \$115,000.00, roll call vote 5 aye 0 nay, motion carried.
